CORRIGENDUM ORDER

1. In the said matter an order No. CEC/SD/D/39-44/2017/120 dated 17/06/2022 was passed by this Authority. The counsel for claimant, in the said matter has filed an application dated 23/06/2022 seeking correction of typographical error in the said order dated 17/06/2022.

- 2. Accordingly the issue has been examined and after scrutinizing the order it has come to the notice that inadvertently typographical mistake occurred in the memo of parties, as the name of the deceased workman has been mentioned as "Bhura Lal" instead of "Bhura Ali".
- 3. Since Rule 32(2) of the EC Rules, 1924 provides that if any arithmetical or clerical mistake occurred in the judgement which has been pronounced and signed by the Commissioner Employee's Compensation, then the Commissioner Employee's Compensation to correct clerical or arithmetical mistake arising from any accidental slip or omission.
- 4. Since only typographical mistake has occurred in this order and there is no need to summon opposite party before deciding the application in question. Accordingly as per Rule 32(2) of the EC Rules, 1924 read with section 151/152 of CPC, the order is partially modified to the extent only in the memo of parties and accordingly the name of deceased employee may be read as "Bhura Ali" instead of "Bhura Lal".
 - 5. Other content of the order dated 17/06/2022, shall remain the same.
 - 6. Accordingly application dated 23/04/2022 filed by Counsel for claimant is allowed and disposed off.
