
ORDER

In partial modification to the earlier order no. F. No. 27(11)/CIF/Lab/98/1752-1762 dated 10/06/2016 and F. No. 27(10)/CIF/Lab/2016/751 dated 13/06/2016 w.r.t. work distribution of Asst. Directors (ISH), the Districts under control for enforcement of the Factories Act, 1948 and Rules assigned to the Asst. Directors (ISH) are **withdrawn** with immediate effect. The work (Investigation of complaints/Accidents) amongst Asst. Directors (ISH) will be allocated by Director (ISH) on rotation basis strictly serial wise as per receipt no. of the diary. Complaints without signature of workers and anonymous/bogus complaints shall be filed without inspection. The record of such allocation of work shall be kept by PA to Director (ISH). The files related to respective Districts will be put up by Asst. Directors (ISH) to the respective Dy. Directors (ISH) of the said district. Assistant Director (Medical)-cum-Certifying Surgeon shall carryout inspection only on factories where medical examination by certifying surgeon is mandatory and he will take prior approval on file from Director (ISH). The other references (except complaints/accidents) for inspection and overall supervision with respect to reporting and other official purposes etc. will remain as follows:
