Claimant Sh Ranbeer Singh filed claim under the Employees Compnsensation Act 1923 for seeking Injury Compensation from the respondents jointly or severely. The brief facts of the case is this that claimant was appointed by the Resp. No 3 Contractor on the post of Karigar on Bread Maker Machine in the month of January 2011 on last drawn wages Rs. 11890/- per month On 22/12/2016 during the course of employment claimant met with an accident while he was working on the bread maker machine and got grievous injuries on left hand, thereafter he was taken for treatment at Pashchimi Hospital for treatment. It is submitted that at the time of accident management has not provided ESIC facility to him for this he has filed his claim before the respondents under the provision of EC Act.

Reply, rejoinder filed by the parties on record. After series of meetings and discussions respondent No 2 counsel filed application dated 11/10/2021 on record, submitting that both the parties have reached on agreement to settle this case in terms of full and final with the consent of claimant as well as his AR as per terms and conditions of Annex A, in terms of Rs. 350000/-. Accordingly application in question and mutual settlement deed dated 08/11/2021 arrived between the parties have taken on record,

Claimant has consented that this settlement has been arrived as per his wish and there in no compulsion on him in this regard.

In view of mutual settlement deed dated 08/11/2021 respondent No 2 M/s Shri Shakti has paid Rs. 350000/- through Account payee cheque bearing No. 428660 dated 11/10/2021 in favour of claimant Sh. Ranbeer Singh. The said cheque has been handed over to claimant Sh. Ranbeer Singh today before this authority. Accordingly by virtue of this mutual settlement deed present case is disposed of being the matter settled as application filed by respondent no 2 dated 11/10/2021 is allowed. It is made clear that respondent o 2 insure that this cheque shall be honored failing which settlement deed shall be deemed terminated, thereafter this court shall take action accordingly.
