Proceeding-cum-Order Sheet

The matter was listed on 07.09.2021 at 2.00 P.M. Today i.e. on 07.09.2021, the claimant and Adv. of claimant appeared with opposite party and stated that she wants to withdraw the matter as the matter has been settled between them amicably by mutual discussion and filed copy of settlement deed dated 07.09.2021 duly notarized by Notary Public. The claimant stated that she was under no force or coercion at the time of settlement. The claimant stated that in terms of settlement, she has received Rs.2,10,000/- through pay order no. 775950 and 775949 dated 06.09.2021 drawn on UCO Bank, Karkardooma Court Branch, Delhi for a sum of Rs. 60,000/- and Rs.1,50,000/- respectively. It was also stated by the claimant that the matter was settled at a sum of Rs.4,20,000/- and out of which she has received Rs.2,10,000/- and remaining amount will be received by her at the time of quashing of FIR. It was stated by both the parties that they will cooperate each other in quashing of FIR. All the statements were made by claimant in presence of her A.R. and she also received the above mentioned pay orders in presence of her A.R.. After receipt of the payment, claimant/A.R. of the claimant requested to close the matter is settled and withdrawn, therefore, the matter is closed as settled and withdrawn.
