## PROCEEDING-CUM-ORDER SHEET

- 1. The claimant has filed an application dated 10.02,2021 under the Employees compensation Act, 1923 (herein after referred as an "Act") wherein it has been stated that her husband Sh. Prabhat Kumar working as engineer with the respondent met with an accident on 12.12,2020, while going from Delhi to Mecrut on his bike with Truck No. RJ05 GC1161 and died on the spot. FIR No. 0771 2020 dated 12.12,2020 was registered. His age is stated to be 30 years and last drawn wages is stated to be Rs. 23,300/- per month. The claimant has prayed to direct the respondent to pay compensation.
- 2. Notices were issued to respondent. Respondent stated that the claimant has filed the same matter before the MACT court of district Saket and has requested to dismiss the claim.
- 3. Rejoinder was filed by claimant side denied the contents of reply and reitereating the contents of claim.
- 4. During the proceeding on 28.09.2021, AR of one fraction of the claimants (Smt. Rajni, Chanchal, Jyoti & Aditya Verma) stated that similar matter is pending before Dr. Hardeep Kaur, Ld. MACT Court, Saket vide claim petition No. 62/21 and the next date in this matter has been fixed before MACT court on 07.03.2022.

Marsing

AR of other claimants (Smt. Sunita, Gautam Kumar and Kamlesh Kumar Singh) and respondent stated that they will verify the same. AR of the claimants (Smt. Rajni, Chanchal, Jyoti & Aditya Verma) stated that he will file supporting documents on next date. But thereafter none appeared on behalf of the claimants.

- 5. Today Sh. Naresh Sharma. Adv with Sh. Thomas. Manager Sales & Services of the respondent is present and filed copy of proceeding dated 26.02.2021 held before PO-MACT, Saket Court in MACT Case No. 62/21 titled as Rajni V/s Ramji Lal alongwith certificate under section 65 B of IT Act.
- 6. On perusal of the proceedings held before PO-MACT, Saket Court, it is clear that the similar matter is pending before MACT court also. The claimants also did not appear after 28.09.2021. Therefore the matter is being closed as dismissed. However liberty is granted to claimants to get the matter reopened, if the same matter is not covered under MACT Act.
