Introduction:

Ministry of Labour & Employment has developed e-Shram portal for creation of a comprehensive National Database of Unorganized Workers (NDUW) verified by Aadhaar for all types of unorganized workers such as Building and Other Construction Workers, Agricultural Workers, Domestic Workers, and other similar sub-groups. The registration of workers in the portal has commenced from August 2021.

Requirements:

The data of registered unorganized workers on e-shram portal is being shared by Ministry of Labour & Employment with the States/UTs for the purpose of matching, verification and for extending benefits of social security/ welfare schemes to them based on their eligibility. For this purpose, the Labour Department, GNCTD intends to develop necessary API through which data can be consumed.

The Labour Department, GNCTD has requested DBOCWWB, which registers construction workers (who are also unorganized workers) to host this data on the server of DBOCWWB, in a well-defined structured format like database-based repository. It is further envisioned that the eShram data points on the DBOCWWB server needs a continuous sync up with the e-Shram data points on a regular interval.
