No. ED3 (Misc.) /DMRC/Lab-EI/08:- In exercise of the powers conferred by clause (a) of section 3 of the Bombay Lifts Act, 1939, as extended to National Capital Territory of Delhi read with sub-section (1) of section 8 of the said Act, the Lieutenant Governor of the National Capital Territory of Delhi is pleased to confer the powers of Inspector of Lifts on the following officers of the Delhi Metro Rail Corporation Limited for a period from the date of issue of this notification upto 21/06/2013.

2. That the above mentioned officers shall exercise the powers and perform their respective functions in respect of lifts and its installations located and installed in the premises owned and controlled by Delhi Metro Rail Corporation Limited.


3. However, the Delhi Metro Rail Corporation Limited will ensure that they will not be Inspector of Lifts in respect of lifts installed in any other building not owned or controlled by the Delhi Metro Rail Corporation Limited in the National Capital Territory of Delhi.

4. The powers of Inspector of Lifts conferred on officer of DMRC namely Shri. Sharat Sharma, Executive Director/Electrical under clause (a) of section 3 read with sub-section (1) of section 8 of the Bombay Lifts Act, 1939 as extended to N.C.T. of Delhi vide Department of Labour, Government of NCT of Delhi Notification No.ED3(Misc.)/DMRC/Lab-EI/08/9068 dated 26.12.2008 stand withdrawn with immediate effect.
