1. The matter was taken on copy of FIR No. 0030 dated 01.12.2021 regd. in P.S. G.T.B. Enclave, Shahdara, Delhi.
2. Notice was issued to the respondents. Respondent No. 1 filed reply mentioning therein that they have given their building on rent to respondent No. 2 and have enclosed copy of rent agreement and requested to discharge them from the matter.
