ORDER

The following re-distribution of work amongst all the Dy. Electrical Inspectors & Asstt. Electrical Inspectors notified as 'Inspector of Lifts' to perform and exercise the functions and duties under the Bombay Lifts Act, 1939 as extended to NCT of Delhi and also allocation of districts among Electrical Overseer to assist notified lift inspectors in discharge of their functions specially carrying out inspection of lifts (periodical as well as in reported accident cases) is ordered with immediate effect in the Electrical Section.
