No. F.3(39)/2/96-LC/Estt./814.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution read with the Government of India, Ministry of Home Affairs, Notification No. F.24/78/68-DH(S) dt. 24th September, 1968, the L.I. Governor of the National Capital Territory of Delhi, after prior consultation with the Union Public Service Commission, is pleased to :—

- (i) make rules in the schedule hereto annexed regarding the method of recruitment and qualification necessary for the appointment to the post of Electrical Inspector in the office of the Labour Commissioner, Government of NCT of Delhi and
- (ii) to cancel the Recruitment Rules for the post of Electrical Inspector in the office of the Labour Commissioner, Delhi Administration, Delhi, notified in the Schedule to Services-II Department, Delhi Administration, Delhi Notification No. F.2(29)/83-S-II dated 7-1-1985 as amended from time to time.

Note 2 : The qualification(s) regarding experience is/are relaxable at the discretion of the UPSC in case of candidates belonging to Scheduled Castes or Scheduled Tribes. If at any stage of selection the UPSC is of the opinion that sufficient number of candidates from these communities possessing the requisite experience are not likely to be available to fill up the posts reserved for them.

The Departmental Officers in the feeder category who are in the direct line of promotion will not be eligible for consideration for appointment on deputation.

Similarly deputationist shall not be eligible for consideration for appointment by promotion.

Period of deputation (ISTC) including period of deputation (ISTC) in another ex-cadre post held immediately preceding this appointment in the same or some other organisation/department of the Central Govt. shall ordinarily not to exceed three years. The maximum age limit for appointment by deputation (ISTC) shall be not exceeding 56 years as on the closing date of the receipt of applications.
