No male candidate who has more than one wife living or no female candidate who has married a person already having a wife living shall be eligible for appointment in case of direct recruitment provided that the Administrator, Delhi may after being satisfied that there are special grounds doing so, exempt any such candidates from the operation of this rule.	4. Where the Administrator is of the opinion that it is necessary or expedient so to do, he may by order for reasons to be recorded in writing relax any of the provisions of the rules with respect to age or category of persons/posts.	5. The crucial date for determining the age limit mentioned in column 6 of the recruitment rules will in each case, be the closing date for receipt of applications from candidates in India (other than Andaman & Nicobar Islands and Lakshadweep). In respect of posts the appointments to which are made through the Employment Exchange, the crucial date for determining the age limit will, in each case be the last date up to which the employment exchange are asked to submit their names.
