The sealed quotations will be opened on 24th June 2022 at 3.00 P.M. The vehicles are available for inspection from 11 00 AM to 3.00 PM on all working days.

The Bidders may drop their original bids/applications along with an Earnest money of Rs. 25,000/- by way of Demand Draft in favour of "Labour Commissioner, Labour Department, GNCT of Delhi, 5- Sham Nath Marg, Civil Delhi - 110054 ". The Bidders or their representative (not more than one) may be present, if they so desire at the time of opening of quotations.

4. The quotations received in time will be opened in the chamber of Dy. Labour Commissioner (C.T) 'c' Block, 5-sham nath marg Delhi- 110001. The Bidders or their representative (not more than one) may be present, if they so desire at the time of opening of quotations.
