
**Sub: Regarding the distribution of COVID-19 vaccine in industries/

Sir,

This is with reference to 1<sup>st</sup> Meeting of the State Level Steering Committee- Delhi for the distribution of COVID-19 vaccine in factories/establishments/ shops etc. In this regard, Govt. of India is exercise of devising mechanism for Universal Immunization Programme of COVID-19.
