## <u>Order</u>

1. Vide order of even no. dated 20.12.2021, respondent no.1 Sh. Inderpal Singh was directed to deposit compensation amount of Rs.14,59,800/- alongwith Simple Interest @ 12% per annum w.e.f. 22.09.2021 till the date of payment plus Rs.5,000/- by way of demand draft/ pay order in favour of

- 2. That Sh. Inderpal Singh@ Goldy, Respondent No.1 requested for time to file reply to show cause notice and the matter was fixed on 30.12.2021 and he again requested for time to file reply to show cause notice and the matter was fixed on 07.01.2022. The matter could not be taken up on 07.01.2022 due to surge in Covid-19 cases and again show cause notice was issued to Sh. Inderpal Singh, Respondent No.1 but neither anyone appeared on behalf of Respondent No.1 nor any reply was received and therefore the present order is being passed.
- 3. In view of above, since the respondent no.1 i.e Sh. Inderpal@Goldy, R/o 978, Chand Mohalla, Gandhi Nagar, Delhi-110031 has admitted the employer-employee relationship between him and the deceased Sh. Vijay Kumar and occurrence of accident in which the deceased Sh. Vijay Kumar expired on the first date of hearing, therefore, a lenient view is taken and a penalty of 20% of compensation amount amounting to Rs.2,91,960/- is imposed on Sh. Inderpal Singh.
- 4. That as decided above, the Respondent No-1 Sh. Inderjeet Singh is hereby directed to deposit the compensation amount

Rs. 14,59,800/- (Rupees Fourteen Lakh Fifty Nine of Thousand Eight Hundred Only) alongwith simple interest till the date of @ 12% per annum w.e.f. 22.09.2021 payment of the same plus Rs. 5000/- plus penalty amount amounting to Rs.2,91,960/-. by way of Demand Draft / Pay **Employees** "Commissioner of favour Order in Compensation-VIII" within 30 days from the date of issue of this order, failing which proceedings to recover the amount of compensation as well as the interest, as an arrears of land revenue, shall be initiated as per the provisions of Section 31 of the Act.
